

# COUNCIL VOLUNTEERS PERSONAL ACCIDENT COVEF

The Insurer will pay the following in relation to a Volunteer from an Injury which occurs while engaged in or on any authorised voluntary work directly or indirectly connected with or on behalf of the Council including while travelling directly to and/or from such voluntary work.

# SECTION A : CAPITAL BENEFITS

This section allows a lump sum benefit to be paid in the event of accidental death or permanent disability resulting from an accident when engaged in voluntary work.

### MODIFICATION BENEFIT

If the Volunteer is paid a capital benefit under any of the payable conditions 2 to 16 inclusive above, the insurer will also pay the cost necessarily incurred by the volunteer in modifying:

- Their motor vehicle
- Home, or
- In relocating to a suitable home

Up to a maximum of \$15,000

### DISAPPEARANCE CAPITAL BENEFIT

If the insured person is travelling on a conveyance and their means of transportation disappears, sinks or is wrecked, and their body has not been found within one vear, the insurer will presume they have died as a result of Injury and will pay the Death Benefit of \$300.000.

# SECTION B: WEEKLY BENEFITS - INJURY (APPLICABLE TO SALARY/WAGE EARNERS ONLY)

This section only applies to volunteers who are employed outside of the voluntary work for Council. In the event that a volunteer of council is injured whilst in their capacity as a Council volunteer and as a result cannot attend their normal course of employment and suffer a loss of income as a consequence, then this section will pay:

- a. Temporary Total Disablement 100% of average weekly income up to a maximum of \$3,000 per week
- b. Temporary Partial Disablement

75% of average weekly income up to a maximum of \$2,250 per week

This benefit is payable up to a maximum of 156 Weeks (3) years) from date of claim

### SECTION C: INJURY ASSISTANCE BENEFITS

This section will cover 100% of actual non-medical related expenses incurred for home help, child-minding, travelling and the like up to a maximum of \$20,000.

#### SECTION D: NON-MEDICARE MEDICAL **EXPENSES**

The benefits in this section are to a maximum of \$20,000 per person.

The benefits provided under this section of the policy can only be provided by the insurer as allowed under the provisions of the Private Health Insurance Act 2007, specifically Part 4-2 and the Rules attaching to the Act.

That is cover can only be provided where a volunteer is providing services to an educational, religious, charitable, benevolent, sporting or youth organisation, directly or indirectly connected with or on behalf of the Council.
