CITY OF WHYALLA

CATS BY-LAW 2021

By-law No. 6 of 2021

A By-law to limit the number of cats kept on premises and for the management and control of cats in the Council's area.

PART 1 – PRELIMINARY

1. Title

This By-law may be cited as the *Cats By-law* <u>2021</u> and is By-law No. 6 of the City of Whyalla.

2. Authorising law

This By-law is made under section 90(5) of the *Dog and Cat Management Act* 1995 and section 246 of the *Local Government* Act 1999.

3. Purpose

The objects of this By-law are to control and manage cats in the Council's area:

- 3.1 to promote responsible cat ownership;
- 3.2 to reduce the incidence of the public and environmental nuisance caused by cats;
- 3.3 to protect the comfort and safety of members of the public; and
- 3.4 for the good rule and government of the Council area.

4. Commencement, revocation and expiry

1. Expiry

3.54.1 The following By-laws previously made by the Council are revoked from the day on which this By-law comes into operation¹:

3.5.14.1.1 By-law No- 6 – Cats 2014.²

3.64.2 This By-law will expire on 1 January 2029.3

Note-

- 1. Generally a By-law comes into operation 4 months after the day on which it is gazetted section 249(5) of the Act.
- 2. Section 253 of the Act provides that the revocation of a By-law by another By-law that contains substantially the same provisions, does not affect certain resolutions such as those applying a By-law to a part or parts of the Council area.
- 3. Pursuant to section 251 of the Act, a By-law will expire on 1 January following the seventh anniversary of the gazettal of the By-law.

4.<u>5.</u> Application

- 4.1<u>5.1</u> This By-law operates subject to the Council's *Permits and Penalties By-law* 2018-2014.
- 5.2 This By-law applies throughout the <u>Council's area</u>.

5.<u>6.</u> Interpretation

In this By-law, unless the contrary intention appears;

- 5.16.1 Act means the Local Government Act 1999;
- 5.26.2 **approved cattery** means a building, structure, <u>premises</u> or area approved by the relevant authority, pursuant to the *Planning, Development and Infrastructure Act 2016* for the keeping of cats on a temporary or permanent basis or, for use in connection with a business involving the keeping of cats, that is operating in the accordance with all approvals;
- 5.36.3 except for in clauses 8 and 9 cat means an animal of the species felis catus, which is three months of age or that has lost its juvenile canine teeth;
- 5.46.4 Council means the City of Whyalla;
 - 5.4.1 *identified cat means* a cat that has a microchip implanted in its body containing information that may be used to obtain the current address or telephone number of the owner or other person entitled to possession of the cat.
- 6.5 effective control by means of physical restraint means
 - 6.5.1 a person is exercising effective control of a cat by means of a chain, cord or leash that does not exceed 2 metres in length restraining the cat; or
 - 6.5.2 a person has effectively secured the cat by placing it in a cage, vehicle or other object or structure;

5.56.6 keep includes the provision of food or shelter;

5.66.7 for the purposes of clause 8, a cat (or cats) causes a nuisance if itmeans:

- 5.6.16.7.1 unreasonably <u>interferes</u> with the peace, comfort or convenience of a person, including but not limited to by displaying aggressive nature or creating unpleasant noise or odour; or;
- 6.7.2 damages or otherwise has an adverse impact upon native flora or fauna; or
- 5.6.26.7.3 acts in a manner that is injurious or causes damage to a person's real or personal property; or
- 6.7.4 wanders onto premises without the consent of the owner or occupier of the premises; or
- 6.7.5 defecates or urinates on premises without the consent of the owner or occupier of the premises;

- 1.1.1 obnoxious, offensive or hazardous to health;
- 6.8 **owner** of a cat has the same meaning as in section 5 of the *Dog and Cat* Management Act 1995;
- 5.76.9 premises includes any land (whether used or occupied for domestic or non-domestic purposes) and any part thereof; and except an approved cattery.
- 6.10 the **person responsible for the control of a cat** has the same meaning as in section 6 of the *Dog and Cat Management Act 1995*.

Note-

Section 14 of the <u>Acts</u> Interpretation Act 1915 provides that an expression used in this By-law has, unless the contrary intention appears, the same meaning as in the Acts under which the By-law –is made.

PART 2 – LIMITS ON CAT NUMBERS & CAT CONTROLS

6.7. Limits on cat numbers

6.17.1 Subject to <u>this</u> clause 7, a person must not, without the Council's permission keep, <u>or</u> <u>cause suffer or permit to be kept</u>, more than <u>two (2)</u> cats on any premises.

7.2 Subclause 7.1 does not apply to premises comprising an approved cattery.

7.3 The Council may require that premises that are the subject of an application for permission to keep additional cats, must be inspected by an authorised person for the purpose of assessing the suitability of the premises for housing cats.

6.27.4 Permission under subclause 7.3 may be given if the Council is satisfied that:

- 6.2.17.4.1 no insanitary condition exists <u>or is likely to arise</u> on the premises as a result of <u>the keeping of cats; and</u>
- 6.2.27.4.2 a nuisance is not <u>or is not likely to be</u> caused to any neighbour as a result of the keeping of cats on the premises.;

all cats kept on the premises over the age of six months are desexed unless the person obtains a letter signed by a veterinary surgeon indicating that this would be injurious to the health of the cat or, that the health of the cat will be jeopardised if it is desexed before a stated age.=

PART 3 – CAT CONTROLS

2. Cats to be identified by way of microchip

Subject to clause 11, a person must not, without the Council's permission, keep in any premises a cat unless the cat is an identified cat.

7.8. Cats not to be a nuisance

7.18.1 An owner or occupier of premises is guilty of an offence if a cat (or cats) kept or allowed to remain on the premises causes a nuisance.

- 8.2 Without limiting liability under clause 8.1, the owner of or person responsible for the control of a cat is guilty of an offence under this By-law if the cat causes a nuisance.
- 8.3 For the purposes of this subclause 8, *cat* means an animal of the species *felis catus* (of any age).

2.1.1 noise or odour created by the cat or cats; or

2.1.2 the cats wandering from the premises; or

2.1.3 the aggressive nature of the cat or cats.

8.9. Effective confinement of cats

- 9.1 The owner or person responsible for the control of a cat must ensure that the cat is effectively confined to the premises occupied by that person between the hours of 10:00pm and 6:00am each day unless the cat is under effective control by means of physical restraint.
- 8.19.2 For the purposes of <u>this subclause</u> 9, <u>cat</u> means an animal of the species *felis catus* (of any age).

9-10. Registration of cats

9.110.1 A person must not keep a cat in the Council's area for more than 14 days unless the cat is registered in accordance with this By-law.

9.210.2 An application for registration of a cat must:

- 2.1.4 ______be made to the Council in the manner and form prescribed by Council (if any); and
- 9.2.110.2.1 be accompanied by the fee (if any) prescribed by the Council; and
- 9.2.210.2.2 nominate a person of or over sixteen (16) years of age who consents to the cat being registered in his or her name; and
- 9.2.310.2.3 identify with reference to an address the premises at which the cat is kept; and
- 10.2.4 otherwise comply with any other requirements determined by the Council.
- 9.310.3 Registration under this By-law remains in force until the next 30 June following the grant of registration and may be renewed from time to time for further periods of up to twelve (12) months.

3. Exemptions

9.4 Clauses 7.1 and 8 do not apply to cats kept on premises that comprise a business involving the keeping of cats, including (but not limited to) an approved cattery, provided that the business is operating in accordance with all required approvals and consents.

PART 3 – EXEMPTIONS

- 11. Council may grant exemptions
 - 11.1 The Council may, by notice in writing, on application or on its own initiative, exempt a person (or a class of persons) from the operation of a specified provision of this Bylaw.
 - 11.2 An exemption—
 - 11.2.1 may be granted or refused at the discretion of the Council; and
 - <u>11.2.2</u> may operate indefinitely or for a period specified in the instrument of <u>exemption; and</u>
 - 11.2.3 is subject to any conditions specified in the instrument of exemption.
 - <u>11.3 The Council may, by notice in writing, vary, revoke or add a condition of an exemption.</u>
 - <u>11.4</u> The Council may, in its discretion, revoke an exemption for a contravention of a condition of the exemption, or for any other reason it thinks fit.

PART 4 – ENFORCEMENT

10.12. Orders

- <u>10.112.1</u> If a person engages in conduct that is a contravention of this By-law, an authorised person may order that person:
 - <u>10.1.1</u><u>12.1.1</u> if the conduct is still continuing to stop the conduct; and
 - <u>10.1.212.1.2</u> whether or not the conduct is still continuing <u>-</u> to take specified action to remedy the contravention.
- **10.212.2** A person must comply with an order under this clause.
- 10.312.3 If a person does not comply with an order, the authorised person may take action reasonably required to have the order carried out, and the Council may seek to recover its costs of any action so taken from the person to whom the order was directed.
- <u>10.412.4</u> However, an authorised person may not use force against a person under this section.

Note-

For example, an authorised person may order a person to:

- cease keeping more than the permitted number of cats on that person's premises; or
- take the necessary steps to mitigate a nuisance caused by howling cats.
